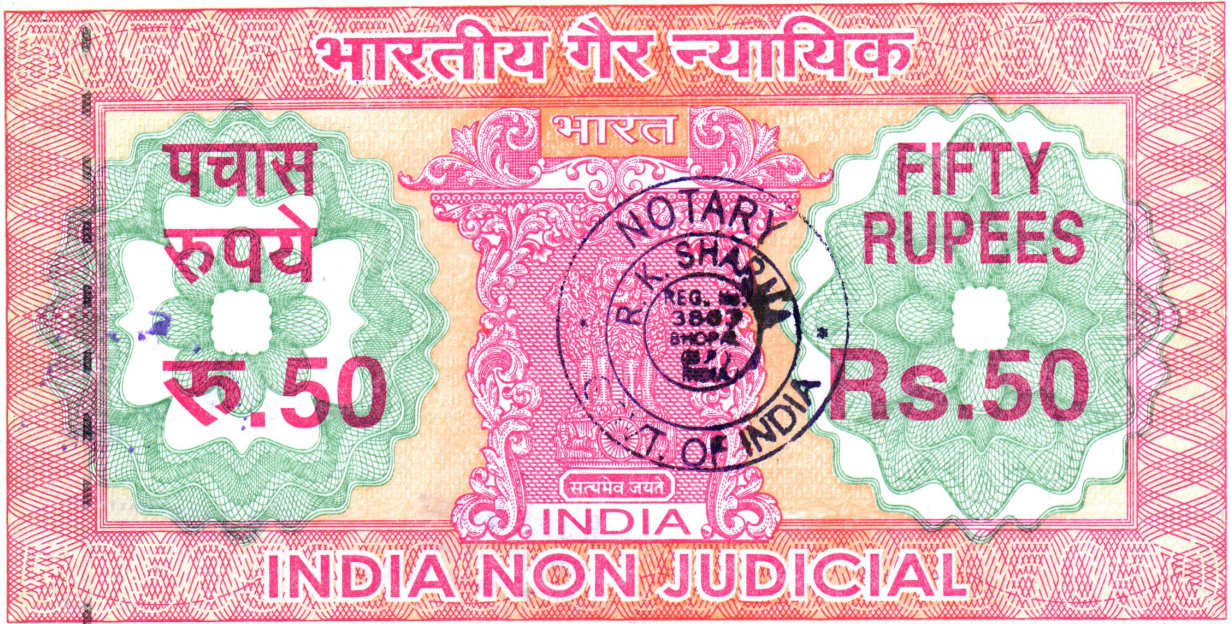

Suraj Nagar, Tehsil Huzur, Dist. Bhopal (M.P.) 462044 for conducting the B.Ed. course. The proposed institution is not conducting any non-teacher education course. Presenting the institution is {not conducting any teacher education course}/{conducting (Number of units.....) units of B.Ed.} course.
- 2- That, on 04th January 2014, the visiting team of WRC, NCTE, Bhopal had conducted the inspection of the proposed institution at **Sharda Vihar Skisha College**, Khasara No. 1/1/36 to continue, plot no. 32, Village Mendora, P.O. Suraj Nagar, Tehsil Huzur, Dist. Bhopal (M.P.) 462044. This very address was mentioned by the society in the application form submitted to WRC, NCTE, Bhopal for the grant of recognition u/s 14 of the NCTE Act/permission u/s 15 of the NCTE Act to start the first unit course of B.Ed.
