**NOW, THEREFORE**, in exercise of the powers vested under **Section 15 (3) (a)** of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition/permission to **SHARADA VIHAR SHIKSHA COLLEGE, SURVEY NO. 44, VILLAGE: MENDORA, STREET/ROAD: KERWA DAM ROAD, TALUKA/MANDAL: HUZUR, TOWN/CITY: BHOPAL, DISTRICT: BHOPAL-462044, MADHYA PRADESH** for conducting **D.P.S.E.** programme of **2 (Two) years** duration with an annual intake of **50 students (One basic unit)** from the academic session **2018-19**.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
